# SELECTED LEADERSHIP ACCOMPLISHMENTS

Sample Program Development – developed and implemented three doctoral programs in educational leadership and instruction [Aurora University (2000), Northern Kentucky University (2009), Kutztown University (2017)] the latter two aligned with and members of the Carnegie Project on the Education Doctorate (CPED); oversaw development of cohort-based, on- and off campus master's programs in education and leadership; envisioned and launched three education outreach initiatives: 1) Center for Professional Renewal at Aurora University (secured a \$1.2 million endowment) to provide for continued rejuvenation of the education profession through in-service education, a sabbatical program for teachers, and sponsorship of future teacher associations in regional high schools; 2) Center for the Renewal of the Education Professions (EKU), worked with legislators to secure a \$1 million recurring budget to fund its operation: and 3) Center for Educator Excellence (NKU) to provide grant support for faculty, inservice education to schools, and evaluation and assessment service for grants and contracts.

Selected Grants, Contracts, & Endowments – conducted a 2-day grant writing "charrette" process with the Colleges of Education and Arts & Sciences at EKU to write a federal technology infusion grant leading to a \$1.2 million award; help secure funding from the "Teacher Quality Action Agenda Trust," Sponsored by Kentucky Council for Post Secondary Education, EKU, State, \$973,000.00 per annum; Secured funds for the "Center for Middle School Academic Achievement," sponsored by KY Department of Education, \$500,000.00 per annum; recruited a donor to endow a \$500K Dean's discretionary fund for innovation (EKU); worked with donor to secure a \$10 million charitable remainder trust for business entrepreneurs (Aurora); secured multiple grants from NASA for Air and Space Science teacher training and student camps; worked with foundations to secure funding for an elementary science/math teacher initiative (Richardson Foundation), increasing math teachers (King Foundation); and established and funded an endowed scholarship in the name of my late wife (NKU).
